## CONSOLIDATED INFRASTRUCTURE GROUP LIMITED (IN BUSINESS RESCUE) - NOTICE OF MEETING OF SHAREHOLDERS IN TERMS OF SECTION 143 OF THE COMPANIES ACT 71 OF 2008

- Notice is hereby given to the shareholders of Consolidated Infrastructure Group Limited (in business rescue) ("Company") pursuant to the provisions of Section 143(3) of the Companies Act 71 of 2008 ("Companies Act") that a virtual meeting of shareholders will be convened for the purpose of procuring a vote in terms of section 143(3)(b) of the Companies Act.
- 2. Section 143(3) of the Companies Act permits a business rescue practitioner, in agreement with the company in business rescue (in this case the Company Consolidated Infrastructure Group Limited), to conclude a fee agreement ("Remuneration Agreement"), if the requisite support is obtained from the creditors and shareholders of the company.
- 3. In order for the Remuneration Agreement to be final and binding on the Company, the following support is required
  - 3.1. the holders of a majority of the creditors' voting interests present and voting at a meeting called for the purpose of considering the Remuneration Agreement; and
  - 3.2. the holders of a majority of the voting rights attached to any shares of the company that entitle the shareholder/s to a portion of the residual value of the company on winding up, present and voting at a meeting called for the purpose of considering the Remuneration Agreement.
- 4. Due to the ongoing COVID-19 pandemic, the number of shareholders of the Company and the current legislated restrictions pertaining to the convening of large gatherings, this meeting of shareholders in respect of the business rescue proceedings of the Company will be convened virtually.
